### TASKS AND RESPONSIBILITIES

The Country Project Manager will support country level programme development and implementation work for ACT in Cambodia and Bangladesh. A particular focus will be on the implementation of mutually agreed priorities, roadmaps and country level commitments and monitoring garment and textile sector development. The Country Project Manager will work in a cross-cutting position and will be the focal contact point for country level project implementation.

- Assisting the Executive Director, Senior Programme Manager and the ACT Member Council in consultations with governments, employers and trade unions in Cambodia and Bangladesh
- Developing country level and cross-country engagement strategies in close collaboration with the Senior Programme Manager and national stakeholders
- Supporting implementation, monitoring and compliance with mutually agreed commitments on a country level
- Developing information and communication material on the ACT process on country levels in close collaboration with the communications team
- Work closely with the International Communications Manager on the development and implementation of country specific communications strategies
